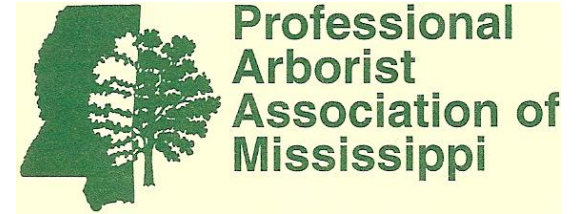
PAAM Mission Statement:
